WHEREAS, THE CITY COUNCIL DESIRES TO CLARIFY THE DEFINITION OF STREET PARKS AREAS TO PROVIDE FOR MAINTENANCE OF THIS AREA BY THE ABUTTING PROPERTY OWNER OR TENANT,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BUTLER, MISSOURI, THAT CHAPTER 21 ARTICLE 1, DESCRIBING STREET PARKS IN THE CITY OF BUTLER, OF THE BUTLER CITY CODE IS HEREBY REPEALED AND THE FOLLOWING ADOPTED IN LIEU THEREOF:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BUTLER, MISSOURI, AS FOLLOWS:

- **BILL NO. 2012-14 ORDINANCE NO. 952
AN ORDINANCE ESTABLISHING CONDITIONS ON LOTS OR LAND THAT CONSTITUTE PUBLIC NUISANCE IN THE CITY OF BUTLER, MISSOURI.
NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BUTLER, MISSOURI, THAT CHAPTER 16 SECTION 34, DESCRIBING WEEDS, VEGETATION AND DEBRIS AS NUISANCES IN THE CITY OF BUTLER, OF THE BUTLER CITY CODE IS HEREBY REPEALED AND THE FOLLOWING ADOPTED IN LIEU THEREOF:
